

## **January 14, 2009 Minutes of the MDMHA Executive, 7 pm, Millbrook Arena**

### **1. Approval of Minutes**

It was moved, seconded and carried that the minutes of the December 2, 2008 Executive meeting be accepted as circulated. (Hartwick, McKie)

### **2. Treasurer's Report**

It was moved, seconded and carried that Lynda Mallon be appointed treasurer as of today. (AuCoin, McKie)

Randy distributed an income statement

Marg reported that she has deposited the court settlement cheques into the investment account with Investor's Group. This is supposed to be a guaranteed account. Randy will check into this.

### **3. Convener's Reports**

#### **3.1 Leo Rep**

Randy will investigate the possibility of getting some professional goalie instruction to enrich the skills development for next season.

Randy asked the Executive for their opinion about the Leo Midget level not being allowed to body check. Our Executive decided against this. Randy will bring this back to the Leo league.

#### **3.2 OMHA Rep**

Jenn reported that there is a movement from OHF towards amalgamating centres and not allowing Representative Teams (rep) to come from anything below a B centre. This could be coming in the future.

#### **3.4 Tournament Convener**

Maggie reported that the upcoming tournaments are all full.

#### **3.5 Team Officials Convener**

Scott encouraged adult members to attend the London Hockey Concussion Summit. It was moved, seconded and carried that MDMHA purchase a 10 DVD set called "Ultimate Hockey Skating" for \$264.32 (taxes and shipping included). (McFadden, McKie)

In regards to police checks, the police representative hasn't completed this yet. Scott inquired about MDMHA having an official pin for trading at tournaments.

### **3.6. OMHA Rep**

It seems that the C centres are being combined with the DD centres for playoffs this season in the Novice level. Notice of this came in late December with no explanation. This will not be able to be changed. This is unfair for the DD players to have to play against the C players. This was not done in the western centres. Randy will draw up a draft letter of complaint for us to finesse and for Marg to sign and send to Bill Needles at OMHA.

### **3.7 Equipment Convener**

Dennes would like the MDMHA to consider buying 4 sets (@150) of home and away jerseys at one time to take advantage of a \$7 per jersey savings. This would represent approximately \$1000 savings. It was decided to wait until after the next meeting to make this decision.
